  This means that knowledge of GCP is an integral part of the exam.

Furthermore you will also find more links to websites in the Source list. It is good to read through this during your preparation, so that you can find necessary information via these links during the exam. (can be found under 4. Sources and literature/4.1 Where can I find it?/Source list):

During the exam, also questions can be asked about websites that can be found in the Source list. Therefore please make sure to carefully study the sites listed above as "important" and make sure you can navigate and search properly via the Source list. This can help you look up things during the exam.

### Mandatory to do, but no exam material:

- 1 elective in-depth module (please note, you may be asked basic questions about medicines. This is because ICH-GCP is also part of the exam!)

### **EXAM TYPES**

Various exam formats are offered. In all cases, the exam is taken by computer. With every exam format you have the option to register for the NL-language or EN-language exam.

#### **BROK** exam on location

This concerns an exam on location at the institution.

## **BROK** Live proctoring exam

Online proctoring makes it possible to take the exam through remote surveillance. All that is needed is a quiet workplace and a stable internet connection. This workplace can therefore also be at your home. During the exam, a proctor watches via the webcam and checks what is happening on your screen via a screen share. In the event of irregularities, the exam may be rejected.

## BROK Proctoring record & view (R-&-R) exam

This is an online exam where no Proctor is watching during the exam, but where the webcam, screen and sound recordings made are later viewed and checked for irregularities. On the day of the exam, you can start the exam at a time that suits you. The entire exam must be completed before 11:00 PM, so that the exam results can be processed correctly. The exam office in Amersfoort can be reached by telephone during office hours (8:00 am - 4:00 pm). Online Techsupport is available all day on your exam date.

#### Extra time:

Candidates who have a disability such as dyslexia or a visual impairment can request additional time for the exam to their <u>BROK® coordinator</u>. The BROK® coordinator must have requested the extra time no later than nine days before the exam to EMWO. #### Time duration

You have a maximum of two hours (120 minutes) to complete the exam.

## Change registration

Changing the registration is possible up to and including 10 days before the exam takes place.

## The exam

The Examination Bureau Medical Scientific Researcher (EMWO) is responsible for administering the BROK® exams. You will be informed about the exam by the EMWO prior to the exam. This message is leading.







## Proctoring exam

The preconditions below apply during the online proctoring exam;

- Well-lit space, clean desk
- You are alone and your upper body is in full view
- Silence and no background noise
- You have a working webcam and desktop recordings are being made
- Sharp face photo and readable ID
- You work with 1 screen, 1 keyboard & 1 mouse

#### Exam on location

The following rules apply to an exam on location:

- You adhere to the rules that apply to the exam room
- You do not cause any inconvenience during the exam
- You only use the equipment to take the exam and to consult digital resources
- You have no contact with others during the exam
- You can identify yourself with a valid ID prior to the exam

## Which materials can you use?

You may consult the eBROK® (<a href="https://nfu-eBROK.nl">https://nfu-eBROK.nl</a>) during the exam, including digital sources and urls mentioned in the eBROK®. Sources in the form of Word, PDF or RTF files from the eBROK environment or the CCMO website may be opened. These files may <a href="https://nfu-eBROK.nl">not be opened from your own explorer or file folder.</a>

Furthermore, you may have multiple tabs open within 1 window of Google Chrome. A candidate who is not a native speaker of English or Dutch may, if necessary, use a translation program such as Google Translate to translate Dutch or English questions. It is also possible to request extra time for the exam in these cases. You can indicate this to the BROK® coordinator.

In the Practical module, under 4. Sources and literature / 4.1 Where can I find it? / Source list you will find a PDF file with all websites and articles that have been discussed in this course. Note: click your right mouse button to open a website in a new tab.

Many abbreviations appear in this course. In the module Introduction you will find an overview of all abbreviations mentioned. If you like, you can download this overview.

### What is not allowed?

You may not consult the eBROK® forum and other websites during the exam. In addition, paper documents and reference work, note paper, etc. are not allowed.

Furthermore, during a proctoring exam you may not:

- take recordings and / or photos of the screen
- use headphones, earphones, smartwatches and similar wearables
- wear a head covering so that the face is not fully visible
- use more than 1 monitor (not even with a laptop)
- use more than 1 browser
- holding and / or using a phone







With an exam on location, you adhere to the rules that apply at the exam location and you always follow the instructions of the exam leader.
